3. Review ALL guidelines.
  - A. Sites and nights-2010- NSCIF Finals will be at Chico State on Friday, March 5 (Division VI and III) and Saturday, March 6 (Divisions IV, V, and II).
  - B. Brackets (12 teams in Division 4 and 6) Reminder that brackets were changed last year, so be sure to know the size of your divisions bracket.
  - C. NO more Foundation games – 26 game total – have schools check their schedules.
  - D. Realignment 2010/11. Leagues need to be sure they have representatives in the realigned leagues for next year.
  - E. Seeding criteria was reviewed and people at the meeting were pleased through division V.
  - F. Look into Division 6 seeding (Bayley). After a long discussion, there was a motion to change strength of schedule ranking for division VI only to hundredths of a point instead of tenths of a point. This will create greater separation and reward teams more for playing up.
  
4. State Information Update- 2010 Rabobank Arena-Bakersfield is the site for State Championships-March 26<sup>th</sup> and 27<sup>th</sup>. It will be a three week format for 2009-10 with an expanded Tournament of up to 16 teams. SEE STATE DATES BELOW.
  
5. Official scratches-In place: Must be done before the season will count on home individual contests ONLY.
  
6. Coaches certification- due 12/31/08-District responsibility. ALL coaching staff. Starting July 1, 2010, AB 1025 will require all coaches in California without a teaching credential to be certified through the state. They will receive a five year certificate. There will be no new requirements, you will just be cleared through the state instead of through your district.
  
7. Model coach nominations- Any school may nominate a coach as a model coach. This year the nominations must be to the section office by November 1<sup>st</sup> since the awards will

be given at the state basketball championships instead of the state track championships. Contact Liz Kyle at the Section Office.

8. Northern Section Advance Bulletin- Please have coaches and A.D.'s review when it arrives.
9. Seeding- Seeding for this year's playoffs will take place Saturday, February 21<sup>st</sup>, at 9a.m. in the Pleasant Valley High School library. All coaches will need to call in and check their scores with the maxpreps.com website for the accuracy of their record. Maxpreps will be used as the official information site for seeding purposes.
10. All Committee representatives please bring the top senior players in your league to the seeding meeting in February. This will help provide the nominees for the section all star game.
