1. Call to Order- 9:03 AM

2. 3. NSCIF Advisory committee responsibility-handout- A reminder was given to all members of their duties including the philosophy to make the section playoffs the best for the section. While the members represent a league to give feedback they must take a section wide perspective when dealing with issues and seeding.

4. Review ALL guidelines.
 - A. Sites and nights-2008- Chico State will be available all day Saturday, March 1st, 2008. Shasta College has been requested for Friday, February 29th. The committee decided to wait for the seeding meeting to finalize sites and which divisions would play at which site.
 - B. Brackets (12 teams in Division 4 and 6)- With the change of division four and six to twelve team brackets, Division 5 will be the only remaining sixteen team bracket. Other than division 5 the remaining brackets will have some first round byes unless teams opt out of the tournament.
 - C. NO more Foundation games after 2007-08- As the second year of the two year scheduling cycle this will be the last year of the foundation games, they have provided minimum income and created a lot of confusion in the Section, so they will be done away with. Starting with 2008-09 all teams will be limited to 26 games and three scrimmages prior to Section Playoffs.
 - D. Seeding criteria- The committee thoroughly reviewed the Section guidelines on seeding and while there are some areas we should look at to provide more equity we have tabled those discussions until April at our wrap up meeting to have everything in place for the next two year cycle.
 - E. Correction to the Guidelines. Item IA Division 6 should be 150 and under for the Division 6 enrollment cutoff.

5. State Information Update- 2007 Arco is the site for State Championships-March 14th and 15th. The tournament will be back to a two week format. Discussions are taking place about going to a three week format for 2009-10 with an expanded Tournament.

6. Model coach nominations- Any school may nominate a coach as a model coach. This year the nominations must be to the section office by November 1st since the awards will

be given at the state basketball championships instead of the state track championships. Contact Liz Kyle at the Section Office.

7. Varsity home uniforms MUST be a white based uniform, not just a light color.
8. Northern Section Advance Bulletin- Please have coaches and A.D.'s review when it arrives.
9. Seeding- Seeding for this year's playoffs will take place Saturday, February 16th, at 9 a.m. in the Pleasant Valley High School library. All coaches will need to call in and check their scores with the maxpreps.com website for the accuracy of their record. Maxpreps will be used as the official information site for seeding purposes.
