- A. I will be an independent contractor and not an employee of the State CIF or its member-Sections, - Leagues or -schools;
- B. I meet or exceed all of the following minimum qualifications for nomination and selection to work the State CIF Football Bowl Championships:
  - (1) I have officiated Football at the HS Varsity level for at least 10 years;
  - (2) I have officiated and/or will officiate, at the position for which nominated, in my Section's finals at least once within the past three (3) years;
  - (3) I will have officiated at the position for which nominated in at least five (5) varsity high school of the games to which I have been assigned for the current season;
  - (4) To the best of my knowledge, I am physically able to work this caliber of Championship Football contest;
  - (5) I am not employee of any CIF Section or State office.
- C. All officials chosen to work in this year's State CIF Football Bowl Championships, will be ineligible to officiate in same for at least the next three (3) years ("alternates" who are chosen but do not actually work a State Football Bowl contest are not subject to the above three-year restriction);
- D. I am available for, and will accept an assignment to, any one (1) of the FIVE (5) State CIF Football Bowl Championship contests;
- E. By signing, I hereby affirm that the information listed in this application is accurate and that I meet all criteria and wish to be placed in the nomination pool. I understand that I am not guaranteed an assignment.
