Action Items:

New Business:

Girls' Report

Girls performed better at 2010 NorCal Championship. Top individual finished in 17th place.

NSCIF participant numbers are still low. General lack of commitment and desire to participate in golf.

Wilcox has offered to host the section championship annually for the girls.

Committee approves Wilcox as the Fall 2011 site for the Girls NSCIF championship. Good location and good preparation for NorCals.

Concern that there are 7 teams in the north and only 4 in the south of our section.

Boys Report

No new business.

General Items

1. Butte Creek wants to charge \$15.00/player for practice and match. However, they will allow free play for certain tournaments. (i.e. NorCals in Spring of 2011)
2. Trinity will participate as part of the SCL.
3. Division and Masters playoff qualifying was discussed and reviewed by the committee.
4. The Masters qualifying proposal from the September 2010 meeting will not be proposed for change until the 2012-14 guideline approval. It will become a working document until officially submitted for consideration for changes for 2012-14.
5. SVL schools will join the MVL beginning in the Spring of 2011. Two champions (1-Division II and 1-Division III) will qualify for playoffs from this combination.

8. Committee agrees that the section needs to continue to play on sites that don't require pay for league matches. We understand that this may be short lived, but for the time being we want to avoid schools having to pay to compete in league matches. All league representatives have been asked to research the costs that their league schools incur to practice/compete on their home venue. The following

schools incur these costs:

Liberty Christian pays Jr. Rate for all golfers to practice and pays for balls

Shasta High pays \$500.00 to practice/play at Gold Hills

Table Mountain has teams donate work days in exchange for practice/play privileges

Greyeagle has schools pay for range balls

League representatives are to also recommend to their league coaches to send a letter of appreciation to the course(s) that allow practice and play for their school.

9. The committee recommends that any school wanting to practice or play on a venue that already hosts another school that the school contact the existing host prior to making arrangements for practice/play as a courtesy to that coach and school. The committee recognizes that the determination of playing privileges at any course is the sole responsibility of the course management, but we don't want to impact a course to the point where the section could lose that venue as a hosting site for school or playoff consideration and/or use.
