SEEDING MEETING @ 9:00 am

All Northern Section League Reps need to attend in order to actively represent the schools of their league during the general meeting and during the play-off seeding process for divisions I, II and III. There should be two league approved representatives from the NAL, BVL, SVL 1, and SVL 2 in attendance to properly represent the teams in each league that will be seeded for post season play.

All coaches are welcome to observe the general meeting and the seeding process but may not participate or lobby for their own teams.

Each school needs to take care of the following as soon as possible:

- 1. The last official day of allowed games is Feb. 10, 2012. All scheduled and make-up games are to be played by this date and the results need to be reported to max preps no later than Friday night Feb 10, 2012.**
- 2. Be sure you are getting your results to Kevin Askeland at www.maxpreps.com. Results must be accurate for proper seeding to be done. If there are any errors please contact max preps immediately to get them corrected.**
- 3. Between Feb 6 and Feb 10 please keep checking the section web side to make sure your W/L/T record is correct/accurate for seeding purposes.**

4. Please be sure to e-mail me or Liz Kyle by Thursday February 9th if your school is going to opt out of the play-offs.

SOCCER COMMITTEE MEETING TO FOLLOW:

This is the general meeting for all the league reps in soccer. This includes reps from the fall, winter and spring. There should be at least two reps for each league that attend this meeting.

Two representatives from the following leagues should be in attendance:

The purpose of this meeting is for representatives of each league to:

- review the duties of the league reps
- review the process of making section guideline changes
- review the section guidelines
- discuss issues that affect school teams in the North Section regarding soccer
- write proposals to suggest guideline changes for soccer that will be beneficial for the sport of soccer, address issues of fairness, or reflect recommendations made by the leagues and schools
- communicate back to all league member schools, information that was dispersed at the soccer committee meeting
