Subject: CIF Wrestling Officials Nominations

We would appreciate your cooperation by e-mailing the attached 2012 CIF Wrestling Officials Nomination application to your qualified associations so they may forward recommendations from your section. The application is an electronic template where nominees must add their pertinent information and attach a 2"x 2" picture in their gray official's uniform.

The process is as follows:

1. Officials Associations should be sent this application electronically from the section office.
2. Associations will then forward to qualified officials who will complete the form and submit it electronically to their respective associations.
3. The associations will email the applications to the Section Commissioners for review.
4. **If possible**, the Section Commissioner should sign the form electronically
5. The Section Commissioner will then e-mail the approved application to Monty Muller at [mullermonty@comcast.net](mailto:mullermonty@comcast.net) and Duane Morgan at [dmorgan@cifccs.org](mailto:dmorgan@cifccs.org).
6. If an official wants to send in a DVD of themselves officiating, to be evaluated, they can send that directly to Ron Nocetti at the State CIF Office. **No more than five (5) matches should be submitted on the DVD. Each match should be a separate clip. These DVD's must be in the state office no later than Dec. 2<sup>nd</sup>.**

To allow for the selection committee to view these nominated officials on the mat, we are asking that completed applications be in our hands by **December 2<sup>nd</sup>**.

The top 10 officials from last years' meet are listed below and need not apply, but they need to be at the interpreters meeting:

# CIF Wrestling Official Selection Process

|        |   |
|--------|---|
| Step 1 | Nomination forms are sent to the CIF Section Commissioners.   |
| Step 2 | CIF Section Commissioners send out to the accredited officials associations within their section.                               |
| Step 3 | Officials association disseminate nomination forms to qualified officials   |
| Step 4 | Officials association return completed nomination forms to their respective CIF Section Commissioner for their signature.       |
| Step 5 | CIF Section Commissioner forwards those signed documents to CIF Wrestling Tournament Head Official and State Rules interpreter. |
| Step 6 | CIF Wrestling Officials Selection Committee selects the 10 new officials.   |

1. It has been implied and assumed that any official who is returning/selected/nominated for the state championships must work the section tournament from which they represent.
2. Also any official who is returning/selected/nominated for the state championships must attend the annual state rules interpreter meeting held at various sites around the state.
3. The only exception would be if that official is working a higher quality event-such as a NCAA Qualifier or have an unforeseen extenuating circumstance, during the section finals and cannot attend-he would be allowed to forgo the section tournament and allowed to referee the state championships. This exception must be granted by the section commissioner.
4. This exception still requires an official to apply through the above process and attend the rules interpretation meetings.
